GENERAL CONDITIONS FOR RESERVATION OF EQUIPPED SITE CATEGORY S

Concerning only the sites for caravans S > 100 m² with private bathroom (shower, toilets and sink) + private kitchenette (sink, hob and fridge) and electricity 10 amps (slightly greater than 2000 Watts).

Reservation for a minimum of 7 nights (3 nights in low season), arrival time after 14h, departure before 12 h, minimum 3 nights.

The deposit fee is FIXED per stay (2 persons per site, and per week).
The fees indicated may be revised.

The booking fee (20€), due for an additional service, are not refundable. Booking fee offered if the whole stay is paid upon reservation.

For any late arrival (after 7 pm) and/or without reservation, support fee (20€) will be charged.

The reservation will not be effective until the deposit has been collected, which must be received **within 7 days** after reception of the reservation voucher.

For all reservations made less than 15 days in advance, the totality of the payment is due upon reservation by bankcard only, offer valid for 48 hours.

For an earlier departure or later arrival no reimbursement is possible, for any reason.

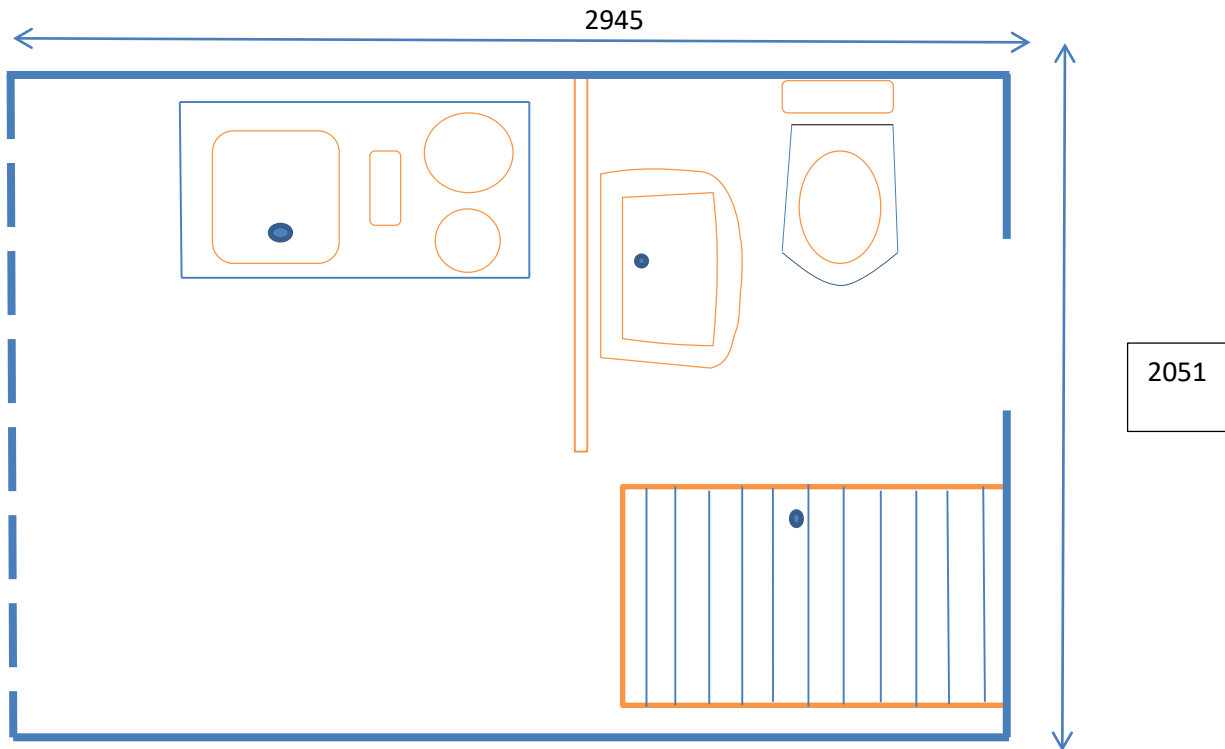
